Housing First is a human right. It's providing people with safe places to live and be able to marshal their thoughts, feelings, and energy toward aspects of their lives that have necessarily been less attended to in the daily effort simply to survive. Housing First is a residential service and program ideal that also provides an opportunity to explore safer self-care and personal aspirations and achievements. How do we cultivate housing services that optimally embody person-centered, trauma aware, and incorporate harm reduction and motivational interviewing? What's the blueprint and best standard of practice? What's needed to provide support to those who live with housing instability, substance use, mental illness, poverty, and discrimination? Let's find out.

Payment Overview

Fiscal & Administrative Review Assistance for IDHS Providers

IDHS disburses funds to organizations in accordance with the payment method specified in the Uniform Grant Agreement. The following types of payment methods may be utilized:

- Advance payments are made in advance of actual grant expenditures. The amount and timing of the advance payment is dependent on the immediate cash requirements of your organization to execute the grant purpose
- **Reimbursement payments** are made only after incurring specific expenditures and submitting supporting documentation to IDHS
- Working capital advance payments are made in advance to cover your organization's initial disbursement needs. After the payment, the reimbursement method typically will be used for subsequent payments

Modifications to Your Award and Budget Revisions

- The total award amount of a grant is subject to availability of funding. It may increase at any time during the period of performance by mutual agreement of both parties. It may be decreased by IDHS during the period of performance. IDHS will provide written notification to your organization in either case
- Approved by IDHS, your organization's budget summarizes the planned expenditures for your project(s) based on the amount awarded by IDHS
- Your organization is required to submit a budget modification request for approval to IDHS if the proposed changes exceed 10% or \$1,000 of a single expense category

Grantee reminders:

- 1. Return unspent grant funds to IDHS within forty-five (45) days from completion of the period of performance
- 2. Submit requests for reimbursement payments to IDHS either within 15 days of the month or quarter end or in accordance with the due date outlined in Exhibit C of the Uniform Grant Agreement
- 3. Maintain advance payment amounts in an insured and interest-bearing account

4. Become familiar with the payment terms in your award

FY 2023 Continuum of Care Notice of Funding Availability Due September 28, 2023 at 8:00 PM EDT

HUD's Office of Special Needs Assistance Programs (SNAPS) posted last week the Notice of Funding Opportunity (NOFO) for the Fiscal Year (FY) 2023 Continuum of Care (CoC) Competition and the renewal replacement of Youth Homeless Demonstration Program (YHDP) grants under <u>Funding Opportunities</u> on HUD.gov. Additional resources will be available on <u>CoC Program Competition</u> on HUD.gov.

The CoC Application, CoC Priority Listing, and Project Applications should be available in *e-snaps* this month. Collaborative Applicants and project applicants will be able to access the applications to review, update, and enter required information for the application process. **All communities are encouraged to apply for the NOFO published on grants.gov** by the submission deadline of September 28, 2023, at 8:00 PM EDT.



OAT and OUTCOMES

As singer/songwriter Kenny Loggins sang, "This is It! Make no mistakes where you are!" August 4, 2023, we close out the Annual OAT Data Collection for SOAR Case Managers for the reporting period of July 1, 2022 – June 30, 2023.

First and foremost, thanks to all that have inquired about the Data Collection process and participated in updating those pending applications in OAT. SOAR is beneficial to so many that are in need of connecting to mainstream benefits (i.e., SSI/SSDI) to end their crisis. According to SAMHSA (2022), In 2022 alone, there were 2,920 approvals on initial applications. Decisions on SOAR initial applications were received in an average of 153 days with an allowance rate of 68 percent. (SAMHSA, 2022)

WHAT SSA WANTS YOU TO KNOW...

Enhanced Representative Availability Process Enrollment

the Enhanced Representative Availability Process, or ERAP, allowing appointed representatives to submit monthly availability for hearings before Administrative Law Judges.

Many representatives have already enrolled in the new process, and we've gotten great feedback! For those of you who have not yet enrolled, it's easy to get started

You can learn about the new process and how to get started on our <u>Hearings and Appeals</u> <u>Enhanced Representative Availability Process (ERAP)</u> page.

Enroll in ERAP as soon as possible. Availability submissions for March 2024, due by October 1, 2023, must be ERAP compliant and will only be accepted from enrolled representatives.

To submit availability for March 2024, you must complete the ERAP enrollment process no later than September 8, 2023. That allows us adequate time to process your enrollment request.

If you are not enrolled by September 8th, you will not be able to submit availability for March 2024 and we will assume you are fully available for scheduling. You can still enroll in ERAP after that time and begin submitting once we have processed your request.
