David A. Harrison "Good Better Best" Award



Don't rest until your GOOD is BETTER and your BETTER is your BEST!

Since 2019, SHPA has honored our former colleague and Board Member, David Harrison, by acknowledging another person or persons from the homeless and housing community who through their own work demonstrate the values that David extolled throughout his long and accomplished career.

For those that did not know David, he was the Program Coordinator in charge of the Madison County Community Development supportive housing and homeless prevention program. Dave was also the Chairperson of the Madison County Continuum of Care/Madison County Partnership to End Homelessness. In addition, he served as a member of the SHPA Board of Directors and was co-chair of the Governance Committee.

Dave was admired for his calm demeanor and his ability to not become jaded. He led by example and was a true public servant. According to his family, friends, and colleagues, he worried about the homeless population and would frequently lament about the shortage of local, state, and federal funding. He worked hard to squeeze what he could out of the available funding to accomplish as much as possible for those in need. He expressed feeling guilty when he was enjoying the comforts of his own home knowing there were people, young and old, trying to survive on the streets. They were not a number or an outcome measure to him, they were human beings.

Additionally, David was described as a leader, a compassionate humanitarian with a BIG heart. He was patient, calm, humble, committed, dedicated, tireless advocate, a voice of reason and irreplaceable. He always kept the needs of the clients uppermost in his mind and heart and never lost his compassion for people in crisis.

We invite all SHPA members to nominate a person or persons who demonstrate these qualities in the work that they do on behalf of our community.

Nomination criteria is as follows:

- This individual, team and/or group must be a representative(s) of a SHPA member in good standing
- Currently works in direct service or administration position
- Demonstrate the same or similar qualities as described above in the areas of Leadership, Humanitarian, Advocacy, Community Action, Public Service
- SHPA Staff & Board of Directors are not eligible.

Fiscal & Administrative Review Assistance for IDHS Providers

Personnel policies guide the way your organization is run and are critical to the successful implementation of grant programs. Effective personnel policies should include:

- Statement of purpose
- Policy statement
- Definitions of key terms
- Clear policy guidelines

Your organization must research, develop, and implement the below personnel policies:

Health Insurance Portability and Accountability Act (HIPAA) Policy	Confidentiality Policy	
Sexual Harassment Policy	Fraud, Waste and Abuse Whistleblower Policy	
Equal Opportunity Policy	Records Retention Policy	
Non-Discrimination Policy	Employee Evaluation Policy	
Americans with Disabilities Act (ADA) Policy	Conflict of Interest Policy	
Drug-Free Workplace Policy	Use of Equipment Policy	

Your organization is responsible for collecting and maintaining personnel records. At a minimum, your organization should collect and maintain the below information:

- Job applications, resumes, hiring process records
- Job descriptions that correspond to departmental organization charts
- Documentation of annual employee evaluations
- Conflict of interest statements
- Training logs and onboarding information

Personnel Policy Reminders

- Memorialize your organization's personnel policies in writing and obtain approval by the appropriate governing body of your organization
- Periodically review and refresh your organization's personnel policies to ensure consistency with Federal and State requirements

SIGN ON TO SUPPORT THE HOUSING ACCESS ACT

Endorse the alignment of housing and services today!

Senators Markey (D-MA) and Alex Padilla (D-CA) introduced the Housing Alignment and Coordination of Critical and Effective Supportive Health Services Act, or the "Housing ACCESS Act." Senators Richard Blumenthal (D-CT) and Cory Booker (D-NJ) cosponsored the bill.

We invite our partners to endorse this bill because it will make a significant impact to both service providers and those who receive these services.

Specifically the bill would:

- Align federal housing and healthcare resources to streamline the creation of supportive housing,
- Make Medicaid reimbursement more accessible for supportive housing service providers, and
- Require a national rate study on housing-related services and supports and other services provided by supportive housing
 providers, certified community behavioral health clinics and Federally Qualified Health Centers that promote integrated care for
 people with complex conditions.

Peer Leadership Development Workshop Opportunity

Last Year's Workshops were a tremendous success and SHPA is pleased to announce that we are launching another round. SHPA is planning to conduct four regional Peer Leadership Development Workshops across Illinois for Person's with Lived Expertise.

The workshop was designed by Peers and will offer interactive discussion and education in Communication, Temperament Styles, Leadership, Emotional Intelligence, Professional Responsibility, Self-Care, Soft Skills and sharing your truth. Each workshop will host speakers with Lived Expertise who will share their experience in becoming a leader including the challenges and skills necessary to fulfil their role. Opportunities for networking will be scheduled as part of the training to encourage Lived Experience opportunities.

The three-day workshop will be available to ten leaders with Lived Expertise, per region and every Peer Leader Development Workshop will be facilitated by a Peer leader.

"I loved connecting with and empowering my Peers." The statewide Peers selected for this workshop will be paid a stipend for attending the workshop, as well as any travel, lodging, or meal expense involved. Upon successful completion of the workshop, Peers may be asked to co-facilitate future workshops with SHPA staff throughout the state and will receive a living wage stipend.
